SECURITY

P.C. P. Fenwick and PCSO N. Pounder outlined the progress being made with the investigations in to the burglaries in Hovingham that took place between 18th and 20th December. This is now a CID investigation.

Currently there is an increase police support time in Hovingham and the surrounding villages. They stressed the importance of keeping doors and windows locked and recommended the use of security lights, alarms, time switches for lights, leaving radios/televisions on and giving dogs freedom of the home as ll act as a deterrent. Householders were reminded to check insurance policies and ensure valuables are itemised.

It was agreed an advisory event with the police on would be held on **Wednesday 5^h February 2014** between 3pm and 7pm in Hovingham Village Hall Community Room.

P.C. P. Fenwick and PCSO N. Pounder then left the meeting.

The provision of street lighting was discussed. It was decided to raise the matter with Mr R. Marr who is to attend the next meeting.
