# **REPORT FROM NORTH YORKSHIRE COUNTY COUNCILLOR MRS C. WOOD.**

- By the end of October the clerk to receive a map showing the areas of grass the NYCC will continue to cut.
- The application to central government for money towards road repairs, with the promise of a contribution from NYCC, had been successful.
- Reduction of bus subsidies has been delayed .
- Managing the budget is a continual challenge.

## REPORT FROM RDC OFFICER MS RACHAEL MARK FORWARD PLANNING OFFICER.

- Ms R. Mark outlined the Local Plan and the sites put forward in Hovingham as one of the service villages. (see map)
- There are concerns and issues over all the sites allocated in Hovingham, especially with reference to the flood plain.
- Discussions to be held with the land owner over how the sites can meaningfully be developed.
- There will be a public consultation early 2015 for the statutory period of six weeks.
- The plan of allocated sites to be completed by the end of 2016.
- Impact of the Community Infrastructure Levy. The Charging Schedule in draft form is out for consultation.

# **REPORT FROM DISTRICT COUNCILLOR R.WAINWRIGHT.**

- Corona Cottage fence. An enforcement notice is being drafted and will be served later this month.
- TESLA who is carrying out a Geological Exploration in the area has offered a payment of £500 for the villages. Councillor R. Wainwright proposed, Councillor M. Wilson seconded and it was agreed, on this occasion, to accept the payment. It was agreed that equal payments be made to Scackleton Action Group, Hovingham Bowls Club, Cricket Club, Tennis Club, Playground and Village Hall.
