MINUTES OF THE LAST MEETING

Councillor P. Chapman proposed, Councillor R. Wainwright seconded and it was agreed to sign the minutes as a correct record of the meeting held on Wednesday 14th November 2018.

REPORT FROM NORTH YORKSHIRE COUNTY COUNCILLOR MRS C. GOODRICK. No report available.

REPORT FROM RYEDALE DISTRICT COUNCILLOR R.WAINWRIGHT.

- The new Chief Executive Ms S. Burlet works four days for Ryedale District Council and one day for North Yorkshire County Council.
- Livestock Market. An independent assessment of the viability of the project is to take place. Depending on the outcome a further more in depth assessment may be commissioned.
- Ryedale House/Public Sector Hub. Further development on this project to relocate the council offices to Wentworth Street has been put on hold. Plans and costings to update and improve the working environment at Ryedale House are being investigated.

GENERAL (Hovingham & Scackleton.

Emergency Plans Review.

- Councillor P. Chapman proposed reviewing the Hovingham Plan and bringing it up to date.
- Ref Scackleton Action Group Minutes. 'It was suggested a similar plan would not be *as* beneficial to Scackleton.'

1918 Armistice Remembered Report

- This had been very well attended. A full church, 18 wreaths laid followed by an excellent lunch in the village hall and a record amount raised for the work of the Royal British Legion.
- A tree is to be planted in each village in commemoration of the centenary of the 1918 Armistice.

Vacancy on the Parish Council.

- No further details until the period of consultation ends on 22nd November.

Village Hall Constitution.

- Councillor M. Wilson reported that the on-going proposal to make the Village Hall Management Committee a Charitable Incorporated Organisation had come to a halt.
- It was proposed that the Village Hall Committee and the Parish Council should arrange a meeting to take the matter forward.

Village Hall Walls Part 2. No further information.

Village/Parish Survey.

Mr F. Colenso a member of the Hovingham Project Purple Group reported.

- The survey forms had been distributed and collected.
- There had been a very high rate of return.
- The information is being collated by an independent body and the results may be available by Christmas.

Winter salt and grit

- Four bags of salt and grit had been delivered to Worsley Arms Farm.
- One bag and a new grit bin had been collected and taken to Scackleton.
- Councillor M. Wilson had topped up all the grit bins in Hovingham.

SCACKLETON

Action Group Report.

- A copy of the minutes of the last Scackleton Action Group meeting had been circulated to Councillors.
- Councillor R. Matthews asked if a Planning Inspector had been appointed to consider the appeal against the Enforcement Notice on the mobile home on land at Scackleton Lane, Scackleton.
- Maisie Milton-Newland, The Planning Inspectorate Room 3E Hawk, Temple Quay House, 2 The Square Bristol BS1 6PN had been appointed.
- All representations must be received by 30th November 2018.
- It was agreed by the Parish Council that the clerk write objecting to this development and supporting Ryedale District Council in taking out the Enforcement Notice.

Remembrance tree.

- It was agreed to purchase the tree from Langlands on the A64.
- Councillor R. Matthews agreed to organise the purchase of this for Scackleton.

HOVINGHAM.

Action Group Report A copy of the report had been circulated to Councillors

- The Playground Committee are still looking for new members to join/take on the steering group.
- Councillors agreed they would discourage the group from closing the playground even for a short period.
- Councillor R. Wainwright asked for clarification on the telephone box.
- Councillor P. Chapman reported that the closure of this facility by BT was imminent at which time it was proposed to purchase the box for £1 and restore it.

Brookside painting of new railings. This work has yet to be carried out.

Electric Vehicle Charging Point.

- Mr F. Colenso – Hovingham Project Purple – gave a presentation on the project to install an ‘On Street’ Electric Vehicle Charging Point in Hovingham Village Hall Car Park.
- Councillor P. Chapman proposed, Councillor R. Matthews seconded and it was agreed to approve Mr F. Colenso’s request to ask two suppliers to carry out a free survey in order to prepare a detailed project plan.

Flood relief channel and surface water study.

- Councillor M. Wilson reported his frustration with the numerous groups who requested detailed information, with photographs, about the history of the work carried out to prevent the beck from flooding.
- The lack of communication among the various groups has resulted in very little work being carried out despite a number of on-site visits and meetings.
- Mr D. Skelton had trimmed and cleared the flood relief channel.
- Councillors agreed to employ Mr R. Carr to clear out the beck downstream between the two bridges starting at Victoria Bridge to avoid additional risk of flooding this winter.
- It was agreed to settle the outstanding 50% contribution to flood channel work for £175 + VAT

- Mr R. Orange-Bromehead would act in a supervisory capacity for the completion of the work on the flood relief channel.
- It was agreed to spend up to £200 on the work.

Location of Armistice commemorative tree.

- Sir William Worsley had agreed to consider the site near the entrance to Hovingham Hall and the church and to obtain information about a recommended variety.

Police Talk on Fraud 15th November Village Hall. For information.

Recycling Area.

- This continues to be a matter of concern despite putting notices around the site and information in the village newsletter.
- Councillors are reluctant to close the site but recognise the facility is used by people from villages other than Hovingham and Scackleton.
- Mr F. Colenso volunteered to clean the blue bins and Councillors thanked him for agreeing to take on this task.

Village seats winter maintenance.

- Councillor M. Wilson and Mr J. Anderson had collected and stored the village seats.
- Mr J. Anderson had agreed to carry out any maintenance.
- The playground seats had been taken to Worsley Arms Farm for over winter.
- Councillor R. Matthews agreed to bring the two seats from Scackleton down to the village.

FINANCE

Finance Update.

Councillor P. Chapman made the following comments on the financial statement.

- No cemetery income had been received.
- Car park income continued to increase steadily.
- Grass cutting grant from North Yorkshire County Council had been received.

Councillors agreed to the following items of expenditure.

- a) **up to £400 for winter salt and grit**
- b) **up to £250 to paint the railings on Brookside**
- c) **up to £100 to supply and fit strimmer guards to posts Brookside**
- d) **up to £100 for grit bin for Scackleton**

- Notification had been received that the subscription would increase by a total of 3.4% to be invoiced in March.

Chairman RDC request for donation to Charity Fund.

- Councillors agreed to make a donation of £50 towards RDC Chairman's chosen charities, Ryedale Special Families and Yorkshire Air Ambulance.
