#### Flood Report from WSP.

- Hovingham Councillors had met and discussed the report.
- Councillors asked that an investigation should start by looking at the gullies to make sure they are all working.
- The project has been handed on to Hannah Cook.
- Clerk contacted Hannah Cook to arrange a meeting with the Hovingham Councillors but has yet to receive a reply.

#### Flower tub on corner by Pilgrim Cottage.

- Agreed to ask Mr R. Wood to purchase a replacement. (See Finance.)

#### Hovingham Quarry Update.

- Chairman had been contacted by a number of residents regarding the noise of the percussion hammer.
- Clerk to make Hovingham Estate aware of the concerns of residents.
- Clerk to make enquiries about unacceptable/acceptable levels of noise.
- It was pointed out that the sound of reversing beepers may be not be solely those of vehicles in the quarry but agricultural vehicles.

#### Noticeboard.

- New track has been purchased and will be fitted soon.

#### Playground Meeting.

- The Playground Committee has yet to hold a meeting.
- Following their meeting a meeting with the Parish Council will be arranged.

#### Recycling Area at the Village Hall.

- District Councillor Mrs C. Docwra had reported that a feasibility study was being carried out on the contents of the black bags to inform Street Scene as to which type of bins it would be best to install.
- Additional bins have been put in the area since Christmas.

#### Refurbishment of white railings round the top green.

- Agreed to accept the quote from CFT Property Matters. (See Finance.)

#### Seat round tree on top green

- Enquiries are still being made to find someone to provide a wooden seat as preferred by the Parish Council.

#### Telephone kiosk update.

- Calls can now be made from the kiosk.
- Refurbishment of the glazing has taken place.
- Repainting to take place by the end of October 2020.

#### Tree in Village Hall Car Park Update.

- A tree surgeon has inspected the tree.
- Advised that the small copper beech growing in to the sycamore should be removed.
- Advised to get the trunk tested to establish the extent of the rot where a limb had been removed.
- If the trunk is sound crown cleaning is recommended.
