Bus Service.</b></p> <ul style="list-style-type: none"> <li>• same timetable now operated by East Yorkshire, the drivers have been friendly and helpful with home drop offs.</li> <li>• Scackleton twice weekly service via Ryedale Community Transport continues, however strict drop off points etc are used.</li> </ul> <p><b>c. Drainage &amp; Flooding.</b></p> <ul style="list-style-type: none"> <li>• Meeting with the Environment Agency was cancelled and needs to be rescheduled</li> <li>• Clearing up needed near Pasture House</li> <li>• Drain blocked on Potticar Bank to be reported via Parish Portal</li> </ul> <p><b>d. GP Surgery – Services available in Hovingham</b></p> <ul style="list-style-type: none"> <li>• Penny at the Surgery to be contacted to find out more details of services provided at Hovingham and hours of opening</li> <li>• Request if option for flu and Covid jabs can be done at Hovingham to save transport issues.</li> <li>• Make residents aware of services etc via Notice Boards, Website and Diary</li> </ul> <p><b>e.
